Tourist Statistics: A short note on Surveys adopted

In Kerala , the Department of Tourism has an organized data collection on tourist statistics since 1986 and from 1998 onwards data on tourist statistics is collected from all 14 districts of Kerala . The entire data collection work is entrusted to the investigators of the Department of Economics and Statistics and they are forwarding the month wise tourist statistics of both international and domestic tourists before 15th of every month in the prescribed proforma (copy enclosed) to the Department of Tourism . The methodology adopted is Census Method and they are collecting data from more than 2500 accommodation units all over Kerala every month . At present 53 compilers are deployed for the state wide data collection and Deputy Directors, E&S dept. concerned are the scrutiny officers at district level. They are collecting the destination wise number of tourists visiting Kerala and in the case of international tourists, country wise data is collected. The data is being compiled at state level and quarterly reports are being submitted to the Govt. of India, Ministry of Tourism.

In addition to this, the Department of Tourism is conducting Continuous Tourist Survey (CTS) on regular intervals of time through the consultants having expertise in the field of conducting tourist survey ,analysis ,interpretation of data on profiles etc. The latest CTS has been done for a period of three years from May 2004 to April 2007. Simple Random Sampling (SRS) is the methodology adopted in interviewing the tourists from across the state and through out the year. Based upon the tourists' arrival as recorded in the Tourist Statistics in each district using PPS sampling technique, the sample size of each district for each year has been fixed. Collection of data went through out the year from selected destinations. For these, separate structured and approved questionnaires for foreign and domestic tourists were used.

Objectives of CTS

Following are the listed objectives of the CTS:

- Review the current system and practices of tourism data collection, market research and use
 of information technology for compiling and interpreting tourist data to develop a scientific
 and relevant data management system for the state.
- Profiling tourists demographic, economic, social and cultural, and factors attracting them to Kerala.
- Type of tourists /tourism.
- Determine mode of arrival & important tourist destinations, provide qualitative details and their overall experience.
- 6. Provide qualitative details on the preferences of present attractions and future expectations.
- Evolve criteria to select destination / circuits and infrastructure mix for tourism development with due consideration to carrying capacities.
- Conduct survey outside Kerala (Generating markets) to understand the perception of tourists about Kerala, especially those who are not included Kerala in their travel plan.
- 9. Estimate room occupancy and average room rent in the classified and unclassified hotels.
- 10 .Assess requirements of human resource in tourism industry and suggest plans for their development.

Methodology & Destinations Surveyed:

Sampling: Simple Random Sampling (SRS) is adopted in interviewing tourists from across the state and throughout the year. Sample sizes for each District have been fixed (using PPS sampling technique) for every quarter. The Collection of Data was undertaken by the qualified and trained Datamation Investigators spread in all Districts of the State. Separate structured questionnaires for Foreign and Domestic Tourists were administered for the CTS, after obtaining approval of the Govt. of Kerala's DOT.

The agency has been presenting to the Department of Tourism at the end of each quarter various findings emerging from the CTS; as well as modifying the questionnaires to be administered to various sampled Groups. The yearly reports shows the profile of both national and international tourists, their main attractions, sources of information, preference in tour booking, internal travel, visit frequency, average length of stay, daily expenditure pattern, their mode of arrival, accommodation, their satisfaction with the present destination and their suggestions for improving Kerala as a tourist destination.
