NOTIFICATION OF RULES

(FOR THE CONDUCT OF A.M.U. STUDENTS' UNION
FRAMED BY THE PATRON UNDER A.C.
REGULATIONS, CHAPTER LVI)

As authorised by the Regulations of the Academic Council Chapter LVI (amended by the Academic Council's Resolution No. 15 dated 15-10-1951) I, as Patron of the Aligarh Muslim University Students' Union, has framed the following rules for the guidence of the Students' Union (hereinafter called 'the Union'):—

1. Only whole-time students of the University such as are studying in courses above the Higher Secondary School level (Class XII) shall be deemed to be the members of the Union.

Provided that Scholars admitted to courses leading to M.Phil. and Ph.D. degrees or to the M.S. or M.D. degrees, shall not be members of the Union.

Only members of the Union, as defined in Rule 1, shall be entitled to vote and election to any office of the Union or to membership of its Executive Committee and to be candidates for election to the said office and the said membership of the Executive Committee.


Provided that no student, though a member of the Union under Rule 1, can be elected to any office of the Union or be a member of its Executive Committee, if—

- (a) he has failed to complete the whole course to which he may at any time have been admitted at this University or any other University within the minimum period prescribed for that course; or
- (b) he has failed to clear or complete part of a course that he is currently admitted to within the minimum period prescribed for that part of the course by the Ordinances (Academic); or
- (c) he has been judged guilty of indiscipline or gross misconduct and has been expelled from the rolls of the University or any of the University for a period of six months or more for the offence; or
- (d) there is a break exceeding one academic year between the course last completed by him at this University or any other University and the next course to which he has been admitted; or

- e) the period for which he has been a regular student of this University (excluding Pre-University / Higher Secondary Course) exceeds 5 years; or
- (f) he is in the service of the University or any other Government or Statutory body, notwithstanding that he is on leave.
- (g) he has not completed one academic year as a member of the Union, if he is a candidate for the post of President, Vice-President or Secretary;
- 3. The Election Officer for conducting the elections shall be nominated by the Patron who, on the advice of the Election Officer, may appoint such other officers including Returning Officers, as the Election Officer may need to conduct the election.
- 4. The Election Tribunal shall consist of the Dean, Students' Welfare as Chairman, and two other members, to wit., the Proctor and the seniormost Provost.
- 5. The election shall be conducted in conformity with the above Rules, and, subject to the said Rules, by reference to the provisions of the Constitution of the Union.

- 35. Maintenance of the discipline among students of the University-
- (1) All powers relating to discipline and disciplinary action in relation to students shall vest in the Vice-Chancellor.
- (2) The Vice-Chancellor may delegate all or any of his powers as he deems proper to the Proctor and such other officers as he may specify in this behalf.
- (3) Without prejudice to the generality of his powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him appropriate, the Vice-Chancellor may, in the exercise of his powers, by order, direct that any student or students be expelled, or rusticated, for a specified period, or be not admitted to a course or courses of study in a College, Department or Institution of the University for a stated period, or be punished with fine for an amount to be specified in the order, or debarred from taking a University or College or Departmental Examination or Examinations for one or more years, or that the results of the student or students concerned in the Examination or Examinations in which he or they have appeared be concelled.
- (4) The Principals of Colleges, Heads of Special Courses, Deans of Faculties and Chairmen of Teaching Departments in the University shall have the authority to exercise all such disciplinary powers over the Students in their respective Colleges, Special Centres, Institutions, Faculties and Teaching Departments in the University as may be necessary for the proper conduct of the Institutions, Special Courses and teaching in the concerned Departments.
- (5) Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed by the University. The principals of Colleges, Heads of Special Centres, Deans of Faculties and Chairmen of Teaching Departments in he University may frame such supplementary rules, as they deem necessary for the aforesaid purposes. Every student shall be supplied with a copy of rules so made.
- (6) At the time of the admission, every student shall be required to sign a declaration to the effect that he submits himself to the disciplinary jurisdiction of the Vice-Chancellor and the other authorities of the University.
