If HPCL has developed it for their Distributors, does it have an inability of booking a refill before 21 days of earlier delivery? If yes, which Office/Officer is responsible for introducing such a restrictive and derogatory feature in this software?
- 2. Kindly name the Officer (with contact details like tel. no., email, postal address, etc.) who can be contacted in case the consumer wants to inspect the stock records/other relevant documents of Dealers/Distributors under Section 4 of RTI Act 2005. Can a citizen directly inspect records/documents of a Distributor at his office under this Section? Please also specify the process of intimation before going for actual inspection applicable to HPCL.
- 3. Are all the domestic LPG cylinders in use manufactured after the second quarter of year 2000 restenciled for the appropriate test due date as per revised periodicity of re-testing after my complaint to Chief Vigilance Officer, HPCL and as per your earlier RTI reply to me via letter PLRO/PNK/RTI-139 dt. 26th August, 2009? Please provide me a copy of directive/instruction/order given by DGM (Vigilance) to Chakan Plant In-charge regarding re-stenciling of domestic LPG cylinders after my complaint to CVO, HPCL. Kindly inform me the total number of LPG cylinders that were re-stenciled till date since August 2009.



- 4. Please provide me with the latest amended electronic copy (MS Word or Adobe PDF format) of 'Marketing Discipline Guideline' released by the Petroleum Ministry which is applicable to all Oil Marketing Companies and their LPG Distributors in India.
- 5. Please provide information about the type (domestic/commercial) of LPG cylinder allowed to be used with domestic Gas Water Heaters/Gas Geysers. Is there a system of inspection to detect the misuse of usage of domestic LPG cylinders?

- (1) HPCL has developed the software of HP Gas operation and provided the same to Distributors. The HP Gas package has the provision of booking of refill before 21 days.
- (2) The various documents, stocks and the other documents of distributors are the third party information which is also the information of commercial confidence hence the same cannot be inspected by the individual.
- (3) The re-stenciling activity is the regular ongoing process started from 2 years back being meticulously carried out by the plant. Approximately 55000 cylinders have been re-stenciled from August 2009 to Jan 2010.
- (4) We do not have any letter on record from the DGM(Vigilance) to the plant in-charge, hence the same cannot be provided.
- (5) The copy of marketing discipline guidelines is attached herewith.
- (6) For domestic gas water heaters/gas geysers only nonsubsidised LPG cylinders are to be used available in 19 kg/35 kg and 47.5 kg capacity cylinders.
